STATEMENT BY GOMOA WEST CONSTITUENCY EXECUTIVE COMMITTEE OF THE NATIONAL DEMOCRATIC CONGRESS (NDC)

The Gomoa West Constituency Executive Committee of the National Democratic Congress (NDC) has taken notice of recent media discussions and public statements attributed to Mr. Blessed Godsbrain Smart, popularly known as Captain Smart, regarding an alleged intention to contest in the Party's parliamentary primaries ahead of the 2028 General Elections.

At a duly constituted meeting of the Constituency Executive Committee held on Sunday, 7th June, 2026, at the Constituency Secretariat of the Party, members carefully considered the matter and wish to place the following on record for the information of Party members, supporters, and the general public.

First, the Constituency's official records do not indicate that Mr Blessed Godsbrain Smart is a legitimately registered member of the National Democratic Congress within the Gomoa West Constituency. He has equally

never been a part of any meeting, event or advocacy by any Branch of the Party in the Constituency over the years. Consequently, the Constituency Executive Committee is unable to verify or authenticate claims suggesting any formal association with the Party at the constituency level.

Second, the Committee further notes that Mr Smart has, on various public platforms over the years, associated himself with political traditions outside the NDC, specifically the Convention People's Party (CPP) and the New Patriotic Party (NPP). While every Ghanaian citizen has the democratic right to make political choices and affiliations, clarity and consistency in political identity remain important to maintaining the integrity of Party structures and processes.

Third, the Committee wishes to remind all stakeholders that membership of the NDC is governed by clearly established constitutional provisions, rules, and procedures. Individuals seeking to participate in the internal electoral processes of the Party must satisfy the requirements stipulated under the Party's Constitution and regulations.


Fourth, the NDC has not opened nominations for parliamentary primaries in any constituency. As such, discussions relating to prospective candidacies remain premature and do not form part of the Party's current agenda. At this stage, the Party's focus remains firmly on supporting the Government of President John Dramani Mahama in delivering on its mandate to the people of Ghana and consolidating the gains achieved since assuming office.

Fifth, the NDC remains a democratic and inclusive political organisation that welcomes all persons who genuinely subscribe to its values, principles, and vision for national development. However, participation in the Party's activities and internal processes must always be guided by honesty, respect for Party structures, and adherence to due process.

We therefore encourage all Branch Executives, Party members, sympathisers, and supporters to remain focused on the collective task of building a stronger Party, deepening grassroots engagement, and supporting the NDC Government's development agenda. We urge members to avoid distractions and refrain from engaging in unnecessary speculation that may undermine Party unity and cohesion.

The Gomoa West Constituency Executive Committee assures all members and supporters that the Party remains united, focused, and committed to advancing the interests of the people of Gomoa West and Ghana as a whole.

Together, let us continue to uphold the values of discipline, loyalty, unity, and service as we work towards an even stronger and more victorious NDC.
